


Who is a migrant worker?




- "a person who is to be engaged, is engaged or has been engaged in a remunerated activity in a State of which he or she is not a national"- Art. 2(1) of the UN Convention on the Protection of All Migrant Workers and Members of their Families.
- "a person who migrates from one country to another with a view to being employed otherwise than on his own account and includes any person regularly admitted as a migrant for employment". ILO C097 Migration for Employment Convention (Revised), 1949 (No. 97)-
- Internal or domestic labour migrants

International labour migration: key demographics











International migrant labour concentration

► International migrant workers by income level of countries, 2019




▶ Distribution of international migrant workers by broad subregion, 2019

Migrant workers' rights challenges: an overview

- Right to equality of treatment and non-discrimination
- Right to freedom from slavery and forced labour
- Right to freedom of movement
- Right of migrants to form, join and participate in associations and trade unions
- Right to just and favourable conditions of work
- Right to an adequate standard of living (including access to adequate food, clothing, housing and water)
- Rights to cultural identity
- Right to an effective remedy for acts violating fundamental rights

Paper chains tied visa regimes






"labour migration policies that condition migrants' visas on employment with a particular employer, thus restricting their access to the labour market" (Niezna, 2022: 362)

Exploitative recruitment and labour practices

- Charging of unauthorised recruitment fees
- Threats and intimidation, including verbal and psychological abuse;
- Deceptive contracts with relevant information undisclosed
- Oppressive / depressive working and living conditions
- Wage theft
- Manipulation, physical and sexual violence
- Hazardous and unsafe working conditions





Deprivation of right to family life, social and cultural rights



Many migrant workers face isolation and social exclusion arising from obstacles to their loved ones joining them and denial of other social and cultural rights

Child labour migrants often face heightened insecurities due to their relative inexperience
